## Darnell Young wanted for firing a weapon

Darnell A. Young, 44, of Zion is wanted on a Zion Police warrant on a Class 1 Felony for aggravated discharge of a firearm, Class 4 Felony reckless discharge of a firearm, and aggravated assault.

Zion Police Officers were called to the 3100 block of Elim Avenue at approximately 5 p.m. on Sunday Sept. 22, for a report of shots fired.

Investigation revealed that Darnell Young allegedly fired at least two rounds from a revolver at his, wife while they were both standing outside.

Young then fled the area in a white Nissan Altima which was found later near 19th Street and Hilltop Avenue. Officers and a police canine searched the area but

were unable to find him. Young's wife was not injured in the incident.
